

PRIVACY POLICY

FAIRIUM Ltd. (Cg. 01-09-930824, 1115 Budapest, Etele street 58/A. 8th floor 48, hereinafter referred to as **Data Operator**) as a data controller, on the right to information self-determination and the 2011 CXII Freedom of Information Act. (hereinafter referred to as "**Affected**") that the data provided by the Affected to the Data Controller or the data requested by the Data Controller are voluntary, to the consent of the Person concerned or to the creation of the Contract, it is based on the preceding negotiations and on the data handling required for the performance of the contract as follows. By providing your personal information, the Affiliate expressly contributes to the handling of your personal information.

The Data Manager is the Contributor's consent, the Infotv. Article 5 (1) (a), Regulation (EU) 2016/679 of the European Parliament and of the Council - hereinafter '**GDPR**' - Article 6 (1) (a) and (b) or (f), the following personal data provided by the User in order for the Data Controller to contact the Affiliation, to conclude a contract with, or to the organization it represents, keep in touch:

- name,
- e-mail address,
- telephone number,
- employer,
- job, or
- business card or otherwise other information provided by the Affiliate.

Personal data is processed in a not automated way.

The personal data of the Affected Person is the sole responsibility of the Data Controller; branch manager and assistant; persons responsible for liaison within the sector; IT security specialists and data protection officers. The duration of the data processing shall be from the date of the withdrawal to the withdrawal of the Contribution of the Affected Person or to the existence of a Contractual Relationship, but the withdrawal of the Contribution shall not affect the lawfulness of the data handling effected prior to the withdrawal. You may withdraw your consent by notifying you in writing through any of the contact details below. You may initiate or arrange for the modification and correction of the Person's personal information in these ways. In the event of a change in the law or in the event that its conditions are met, the Data Controller deletes the personal data of the Person who is no longer required to achieve the purpose of the data management.

Your personal information may be transmitted to the Data Manager's contractual newsletter service provider in order to be able to send a message to the Affected Number. The Data Processor may, when storing relevant electronic documents for the Affected Person, be transferred to the Data Controller's contractual electronic storage and mailing system service providers in order to keep the Relevant Data electronically stored. The Data Controller informs the Customer that he or she may request information from the Data Handler for handling his / her personal data and may request access, correction, deletion, blocking of his / her personal data, or the termination of his or her data for a particular purpose or part of it, against his or her personal data. You are entitled to receive your electronically managed personal information in a widely used, machine-readable format. The Affected Party may also request information on the personal data of the data processor processed by the data processor, their source, the purpose, legal basis, duration of the data processing, the name and address of the data processor and the data management related thereto, the circumstances, effects and measures taken to remedy the privacy incident, in the case of transmission of the personal data of the person concerned, the legal basis and the addressee of the transfer.

In relation to data handling, the Affiliate has the remedies provided by Infotv, namely Infotv. Article 21 and Article 21 of the GDPR, as well as the provisions of the Infotv. As defined in Section 22, you may claim your rights and any damages and damages you may be entitled to by law.
